The Anti-ragging Cell is for the entire students of the college and starts its activities from the time of admission and the help desk offers counseling to the newly admitted students in the presence of their parents. The help desk also issues a leaflet to make them aware on not indulging in any kind of activities which comes under the purview of ragging. Anti-ragging Cell is responsible for taking strong action on the basis of the case of any kind of difficulties or complaints raised from any students. An Anti-ragging Squad is thus coordinated to make a keen observation on the activities inside

campus and class rooms especially at the time of fresher's welcome day and other celebrations. . The cell has the power to suspend, not issuing a good certificate of character, or freeze benefits such as scholarships, grand ...etc.

As soon as the academic year begins, programmes and events are organized to raise awareness among the students against ragging and also offers the legal supports against ragging. As part of this, proper guidelines were given to the entire class tutors to conduct counseling session for the concerned classes for familiarizing the code and conduct of the college. Student representatives were selected for vigilant monitoring of the class room interaction of the students.

An invited lecture on 'General Laws' was organized by the Legal Awareness Forum in association with Anti-ragging Cell on February 6, 2019. The programme was officially inaugurated by the chief guest Advocate. Jobin P.S (Vice President, Bar Association, Varkala). He first gave the students a brief idea about the fundamental rights and also insisted the students to be vigilant and know about their rights and duties. He also explained some provisions in Consumer Protection Act and Anti-Ragging Act. The session disbursed at 12.45pm with a valedictory function. The session was presided by Dr. L. Thulaseedharan, Principal SN College, Sivagiri, Varkala. The Legal Awareness Forum Convenor Dr. Vinod C Sugathan (HoD, Department of Economics) delivered the welcome speech.
